Note from Editor: Due to a serious health issue, Tom will not be contributing new articles for awhile. For now, we will dip into his vast archives while he's on the mend. Please keep Tom in your thoughts and prayers.

July 1999

Last month we began working with a common but challenging shot to place you in the foundational stage of control over it. We shall continue working in the same area for two more months to complete your mastery of this critical shot.

Set up the balls beginning with the cue ball at position A and the object ball about an inch from the rail as shown in the diagram. Although we have moved the object ball one diamond down the rail from its position last month all of the same principles will apply as we work through this month's exercise. With the cue ball at position A let's begin where we left off by shooting the object ball into the corner and moving the cue ball across the table on the perpendicular track to hit point X. While we examined reasons for the importance of mastering the perpendicular track last month we did

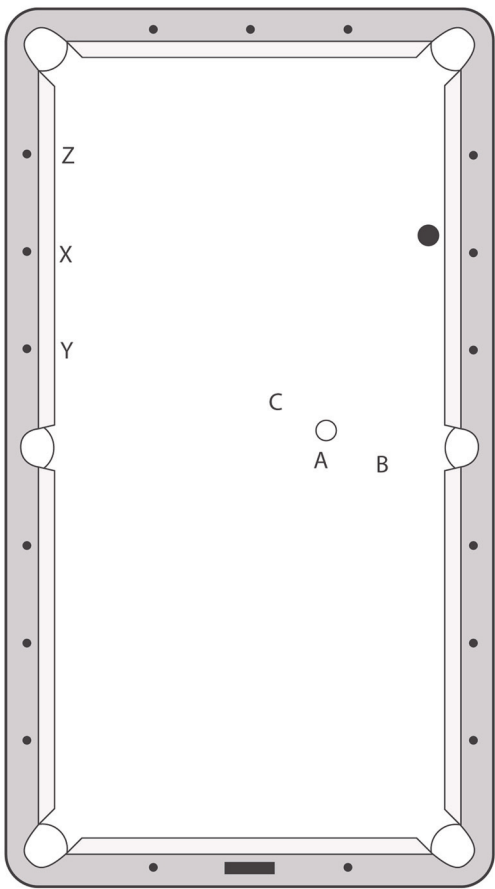


not discuss the larger purpose of such rigid control over the cue ball. Pool players have a number of solid benchmarks in their toolboxes--the stop shot is one--which they use as reference points in planning the execution of position for the next shot. An absolute knowledge that you can execute several key elements of position play will become your source of confidence under pressure and your source of freedom to employ feel for moving the cue ball beyond your reference points. Play the shot a few more times in the context of the perpendicular track becoming one of your benchmarks. From this base we can proceed to moving the cue ball onto different tracks by making adjustments from the reference point.

From point A let's begin to move the cue ball away from our reference to hit the opposite rail one diamond closer to the side pocket, point Y. You can do this by looking at the spot on the cue ball you would hit for the perpendicular track and feeling with your tip a one-diamond adjustment downward on the cue ball. Play the shot and observe the results. With no thought for correctness continue playing the shot and observing what you are feeling on the cue ball as it relates to your benchmark. When you nail down one diamond you can try a

two-diamond adjustment for a scratch in the opposite side pocket. Make a strong note of where that scratch resides on the cue ball for the speed you chose; your awareness of the usual scratches for many shots will become another set of benchmarks.

Divide and Conquer!

In science, the “divide and conquer” algorithm refers to breaking down a problem into more manageable smaller problems until they become simple enough to solve directly. This same concept can be applied to understanding

our pool game and conquering those errors during competition.

With nationals just around the corner, who couldn’t use a little help in conquering those errors?

How many times have you been in a match where it seemed like nothing was going right for you? No matter what you did, it wasn’t working. It can often feel overwhelming when that happens. You make one little mistake and the next thing you know all the errors start snowballing. When you look back on that match, you might be able to pinpoint one or two specific things that resulted in your downward spiral.

If only you could identify it when it starts happening... You couldn’t because all the com-

bined errors clouded the real reason you weren’t getting out. You were looking at the big problem instead of dividing it into smaller ones that you could attack.

Here’s a perfect example:

You lost your match because you missed too many key shots. You missed those shots because you were too tentative and did not deliver a confident stroke. Without confidence you weren’t following through. You didn’t follow through because in the very first rack of the match you over-stroked a draw shot and hooked yourself. Now, instead of adjusting to the table, you’ve managed to make a mountain of a loss out of the molehill of the table speed. If only you were able to recognize what was happening while it was happening.

My personal biggest weakness is when the balls are really dirty. As soon as I’d over-spin that first shot, it would ultimately make me so uncomfortable, it would cause me to jump up or misaim. When you’re not comfortable, it’s difficult to stay down. You just want the shot to be over with.

My point is that if you’re able to break down the equation and quickly identify the problem, it makes it much easier to conquer it. Sometimes

confidence can win as many matches as skill. If you can’t figure out what’s causing you to feel uncomfortable, you’ll never be able to feel confident. When a match takes a turn for the worse, break it down and conquer it! Figure out what’s happening and regain your confidence.

Williams Crowned Platte Valley Open Champion

On April 2-3, the small town of Saratoga, WY, population of roughly 7,500, filled the city with pool players for their fourth annual Platte Valley Open. Locals were treated to some world class bar table 8-ball. “The tournament went fantastic! I’ve loved pool since I was five years old and I can’t get enough of it. It’s a way to get everybody together,” said tournament director E.J. Glode.

In the masters division, 52 of the finest players from Wyoming and Colorado came to try their luck. The \$9,000 added prize money also drew players from the as far as Portland, Oregon and Seattle, Washington. The professional team of “The Rocket” Rodney Morris, “The Hitman” Raj Hundal, and “The Korean Dragon” Charlie Williams also made an appearance.

Four players advanced from each of the original four brackets into a 16-player redraw finals board which started on Saturday night. The first round of the evening saw a finals caliber match between Morris and Hundal. Both players shot quickly and loosely with an outcome of Hundal

advancing 7-5. From Denver, Tony Piazza and Rafael Ibarra both gave it a good run, finishing tied for 5th place.

On the b-side, Piazza was down 5-2 against Portland, Oregon’s Glenn Atwell. The veteran bar table champion began losing his grip allowing Piazza to close the gap and take the lead. While up 6-5, a fatal scratch in the side would cost Piazza that game. At hill-hill, Atwell broke and scratched allowing Piazza another chance for the kill. Uncharacteristically, Piazza missed with ball in hand and Atwell took that match to advance. The Rocket awaited his match with the winner.

Atwell would keep the momentum going against Morris and Hundal. After several failed attempts to run out, Atwell defeated Morris 7-1 and then did the same to Hundal by a score of 7-5 after being down 5-4. Williams went undefeated through the a-side and watched as Atwell took out his travel companions one at a time, shattering the pro team’s hopes of taking 1, 2, and 3.

Williams, who delivered Atwell his first loss, came out strong. He quickly jumped to a 5-0 lead. Atwell had several opportunities but could not capitalize. At 5-0, Atwell made a tricky run to get on the board then proceeded to run the next two racks making it 5-3. It appeared that he was making a comeback until he missed a 9 ball in the side pocket in the following rack allowing Williams to get to the hill. The gentlemen battled over the next couple games until Williams finally gained control in the last rack pocketing the 8 ball for the win. The final score was 7-4.

Pom Rai of Fort Collins, Colorado won the Classic division and Danny Haynes from Rawlins, Wyoming took the Sportsman division. Both men claim through their respective fields without losing a match. Rai came through the 64-player field to meet Denver’s Steve Thomas in the finals after Thomas lost his first match of the redraw. Haynes’ victory of the 48-player field earned him \$400 while Rai pocketed \$1,200.

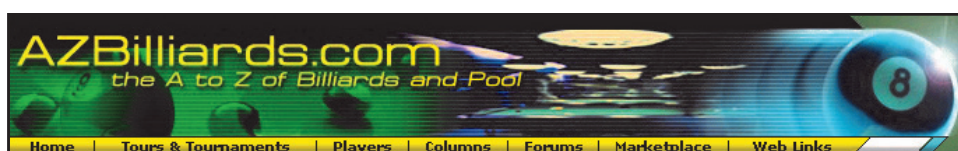

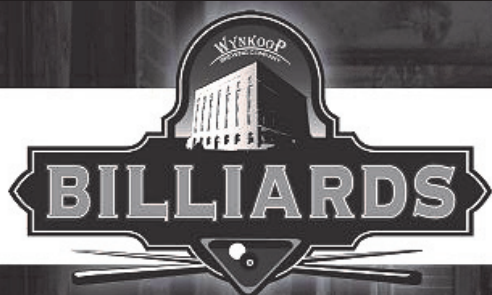

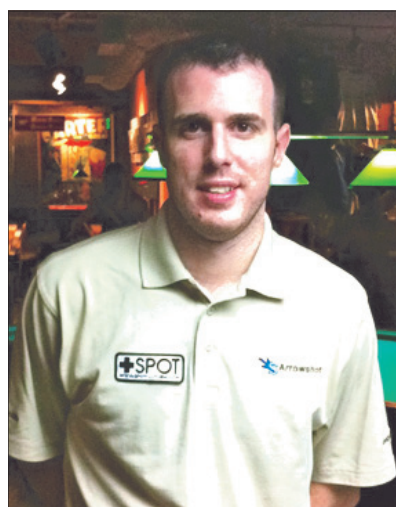
Marc Vidal Wins Denver U.S. Open 10-Ball Qualifier

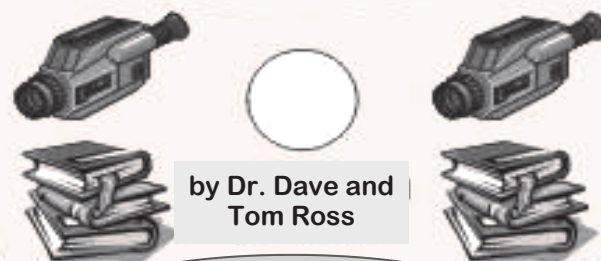

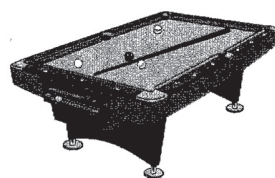

From here you have myriad options and shots to explore in this exercise. While still shooting from point A you can continue with one-diamond downward adjustments on the cue ball to hit each diamond on the opposite rail including the scratch in the lower left corner. Continue in this fashion until you are hitting your very best draw shot and have found the limit of control with draw alone. After you have placed every track on the cue ball with once-across-the-table speed repeat the exercise with enough speed to go twice across the table. Observe how the spots on the cue ball change as you find the same tracks with added speed. Note also your new draw limit with more speed.

You can repeat the exercise from points B and C playing for all of the same tracks again. Find your tracks on the cue ball and

allow them into your memory. You will find some profound differences from the new cue ball positions such as a narrower range from point C and the need for power to get across the table from point B. After this of course you will want to move up on the cue ball to find the tracks you can hit below the object ball beginning with a one-diamond move to point Z. Next month we shall push forward adding english to the cue ball and observing the effects of various strokes.

This exercise is not designed to bury you in hard work and discouragement even though that possibility exists. You can have fun doing this work if you are willing to give up your concern for correctness and explore your feel for the cue ball instead. Imagine yourself as a great musician who remembers a tune with his fingers rather than working it over with his brain. You will experience a huge breakthrough when you begin to feel the desired track on the tip of your cue.

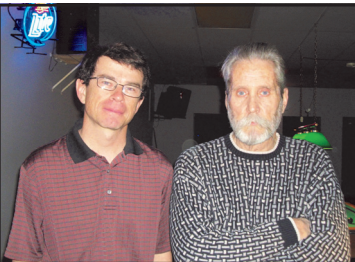

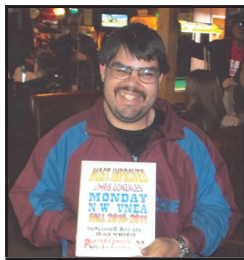

Villarreal and Kiamco Take 18th Annual U.S. Bar Table Championships All-Around Titles

Come snow or shine the U.S. Bar Table Championships (USBTC) held February 21-27, 2011 brings players from all across the globe to “the Biggest Little City in the World.” Hosted at the Terrible’s Sands Regency Casino Hotel in Reno, Nevada, the \$25,250 guaranteed added event celebrated its 18th anniversary in 2011.

The event had over 450 entries in six divisions: Men’s / Mixed 10-Ball, 9-Ball, 8-Ball and Women’s 10-Ball, 9-Ball and 8-Ball. This was the first year in the event’s history to include a full set of women’s divisions and women’s All Around bonuses.

The USBTC is produced by CueSports International (CSI), sponsored by Terrible’s Sands Regency and Diamond Billiard Products, and directed by Bad Boys Billiard Productions. During the event players were paid immediately on-site. Over \$66,000 was available for cash payouts.

The tournament began with the 10-Ball divisions, with 16 women and 93 men. The 9-Ball division started its engine mid-week with 23 women and 128 men. The 8-Ball competition, with 36 women and 157 men in contention, wrapped up the event. After two years of bandwidth issues at the host venue, the innovative team and internet live pool action leaders, TAR, this year was able to live stream.

In the women’s competition, a tornado ripped through all three fields with little mercy. Vivian Villarreal, long time WPBA professional and

fan favorite, took first place in all three women’s divisions. Her dominance solidly secured her the \$500 first place All Around Women’s Bonus.



Vivian Villarreal raked in a cool \$3,050 for her efforts at the Championships.

Competing for the second place women’s All Around included Melissa “The Viper” Little, Nicole Keeney, Brittany Bryant, and Susan Williams. While the points were close, it was Bryant who came in second in the women’s All Around points behind Villarreal.

For the first time in several years, the Men’s / Mixed All Around competition was not dominated by one or two individuals. Instead there were a handful of players who were neck and neck in All Around points throughout the week.

The final board of the Men’s / Mixed 10-Ball division included the diverse crowd of Stevie “the Blade” Moore from Georgia, Canadian Pros Stan Tourangeau and John Morra, Californian Louis Ulrich, Arizona monster Mitch Ellerman, Midwest young gun Branden Ashcroft and 2008 World Pool Master Champion Alex “the Lion” Pagulayan.

Going into the 10-Ball finals between Pagulayan and Morra, the railbirds were putting “The Lion” heavily in favor over Morra. The live stream audience was treated to both men playing dead stroke in the first race to 7. However, two scratches on the break by Pagulayan gave Morra the edge needed to win the first set. Coming from the one loss side, Morra would need to beat Pagulayan again in a second set. It was not to be as Pagulayan came back strong and Morra seemed to lose steam, giving Pagulayan an easy win in set two.

Heading into mid-week Pagulayan led the men’s All Around points with Morra hot on his heels. However in the 9-Ball division both were knocked out much earlier than anticipated. “The Lion” was ousted by Vegas player Ray Skenandore and the kid from Ontario, Morra, was sent to the sidelines by Phoenix player Nick DeLeon. Both Pagulayan and Morra finished 49th-64th place in the division. The gate was now wide open to a slew of other players to pursue the meaty \$2,000 first place Men’s / Mixed All Around bonus.

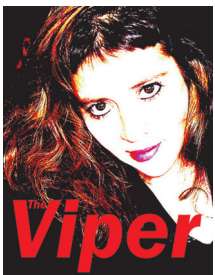

Question:

I know that I need to work on practicing other areas of my game (e.g. safeties, kicks, banks, etc), and I wanted to know about your practice schedule. How often do you practice, for how long, how much attention do you give to safeties, kicks, banks, etc., and are there any specific drills that you would recommend?

Hope to talk to you soon! Aimee Peterson, Aurora, CO

Answer:

Aimee, thanks for the great question!!

For kicks, combos, banks and safeties I do practice drills by setting up those particular shots and shoot them till I feel like I can see and feel them.

When I play alone, I play the game I invented called “15-Rack” but for 45-racks per session- it’s a lot but it helps me focus when I cannot play with someone else. And sometimes I will even do make-up matches with my 15-Rack league players. 15-Rack is playing 10-ball the ghost in a modified statistical scoring way for a total of 15-Racks per session. This game really helps me figure out what I am doing wrong so I can fix and improve on my weaknesses.

Otherwise, I schedule a different workout partner each week to get the total workout package. I sometimes play One Pocket with the players around town who like to play the game, and I’ll even drive to Hank’s and play Mailman George some 3-cushion billiards at least once per month. Most importantly, I try to practice 2-hours a day every day. ☺

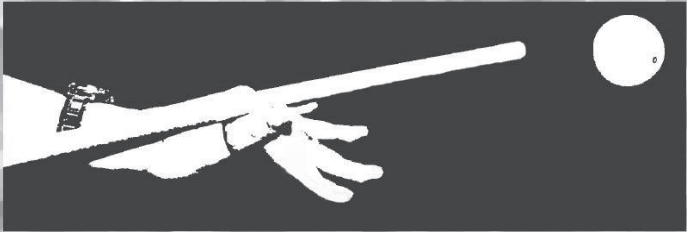

Prime to take advantage of that opening were Moore, Tourangeau and lesser known Tennessee player Josh O'Neal who all cashed high in the 10-Ball division and two additional dangers, Larry "the Truth" Nevel and top Philippine player Warren Kiamco. The finals of the 9-Ball men's division were those very two dangers who uncharacteristically didn't catch the final board earlier in 10-Ball, but earned redemption in the 9-Ball.

Nevel's road to the 9-Ball finals was a long one. After a first loss to Beau Runningen in his third match, Nevel had to grind it through 9 more matches on the one loss side to make it to the mountain. Kiamco was more leisurely in his travel to the finals, enjoying the sweetness of being in the hot seat. The finals came down to Nevel and Kiamco. But even the best grinders can hit a wall. Although Nevel trounced Kiamco 9-2 in the first set, a little déjà-vu of the Pagulayan - Morra 10-Ball final took place. In set two Nevel lost a little steam and Kiamco played solid taking the set 9-6 and first place in the division. Now it appeared there was a new Sheriff in the All Around point list town.

Going into the 8-Ball and final division, there were more horses in serious contention for the USBTC All Around bonuses than the 9th race at Aqueduct.

The top contenders were Kiamco, Nevel, Moore, Pagulayan, Morra, Ashcraft, O'Neal and Tourangeau.

Moore played consistently all week placing 7-8th in the 10-Ball and 5-6th in the 9-Ball. Tourangeau was also one to watch with a 5-6th place finish in the 10-Ball and 7-8th place in the 9-Ball. Although they faltered in the 9-Ball, the 1st and 2nd place finishes in the 10-Ball still put Pagulayan and Morra in solid All Around position. Nevel and Kiamco garnered new life after their 9-Ball finishes and were slightly ahead of Pagulayan and Morra in the point list. Two darker horses but still in contention were Ashcraft with a 5-6th place finish in the 10-Ball and a 17-24th place in the 9-Ball and O'Neal with a solid 9-12th place finish in the 10-Ball and strong 5-6th finish in the 9-Ball.

The top contenders still had to maneuver the 157 player 8-Ball field. Some fared well, some fell to the wayside. The final 8 players included: Amar Kang, O'Neal, Kiamco and Ashcraft on the winner's side and Morra, Moore, Josh Smith and Ivan Doty on the one loss side. Kang, Smith and Doty could only cash in on the All Around bonuses if they won the 8-Ball division.

Kang, Smith and Doty were motivated and potential spoilers to the other 5 players; evidenced when Doty knocked Moore out of the 8-Ball division 5-0. After the dust settled Morra and Kiamco were the last two players standing.

While Kiamco again was the hot seat man, Morra meticulously made his way through 10 matches before facing Kiamco. It must have been the taste of his near 10-Ball victory that spurred Morra as he handily double dipped Kiamco 5-2, 5-2 to take the 8-Ball division title.

With division play over and points list in hand, it was announced that Kiamco took the \$2,000 first place Men's / Mixed All Around bonus, Morra took the \$1,000 second place bonus and the lion that roared early in the week, Pagulayan, squeaked past the rest of the field to take the \$500 third place bonus.

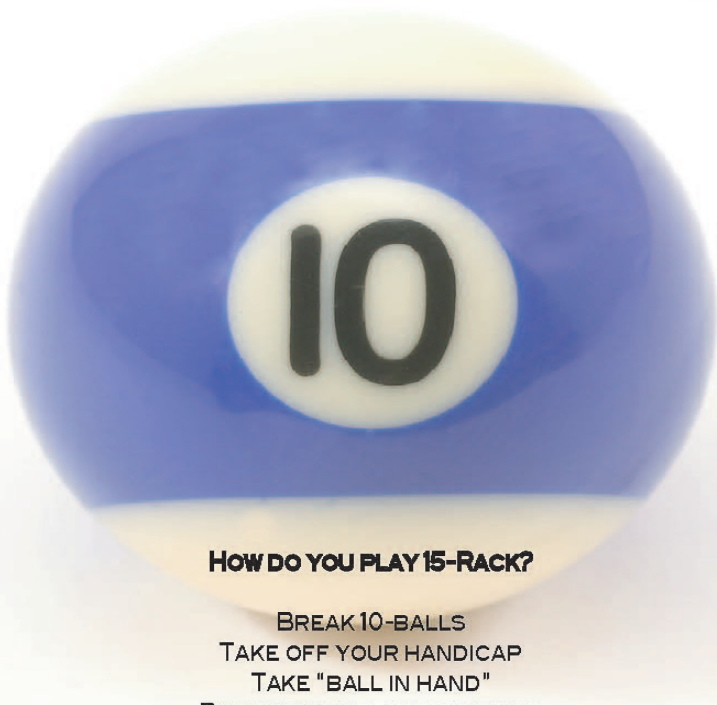
